A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO AMENDMENT #1 WITH APPLIED ECOLOGICAL SERVICES FOR THE KIRTLAND EAST BRANCH CHAGRIN RIVER STREAMBANK STABILIZATION PROJECT, AND DECLARING AN EMERGENCY.

WHEREAS, on January 23, 2019, this Council adopted Resolution No. 19-R-2 authorizing the Mayor to enter into a contract with Applied Ecological Services for the Kirtland East Branch Chagrin River Streambank Stabilization Project; and

WHEREAS, the parties wish to enter into an amendment to the agreement to extend the project completion date from June 1, 2020 to June 30, 2020; and

WHEREAS, the cost of services is unchanged;

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION I: As set forth in the Amendment #1, marked Exhibit "A", attached hereto and made a part hereof, the project period is extended through June 30, 2020; the total cost of services is unchanged.

Amendment #1 to the East Branch Chagrin River Streambank Stabilization Project Agreement with Applied Ecological Services, the terms and conditions of such amendment are set forth in Exhibit "A" attached hereto and made a part hereof.

SECTION III:

- (a) It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121,22 of the Ohio Revised Code.
- (b) That this Resolution is declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that it is necessary to meet the needs of the municipality; wherefore this Resolution shall be in full force and take effect immediately upon its passage by the affirmative vote of five (5) members of Council and approval by the Mayor, otherwise this Resolution shall be in effect from and after its adoption at the earliest period allowed by law.
