## **ORDINANCE NUMBER 22-0-41**

AN ORDINANCE AMENDING SECTION 1068.03 OF THE CODIFIED ORDINANCES OF THE CITY OF KIRTLAND RELATING TO THE DISCHARGING OF FIREARMS, FIRES, AND SIGNS IN THE KIRTLAND RECREATION PARK, AND DECLARING AN EMERGENCY.

WHEREAS, Ordinance No. 85-O-38 was passed on May 20, 1985, establishing Kirtland Code of Ordinance §1068.03 relating to prohibited conduct within the Kirtland Recreation Park; and

WHEREAS, the City of Kirtland desires to amend said section to delineate the person or entity in charge of the park along with the delineating the locations for ingress and egress into the park.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Kirtland, County of Lake, State of Ohio, that:

SECTION I: Codified Ordinance Section 1068.03, enacted by Ordinance No. 85-O-38, passed on May 20, 1985, is hereby amended as set forth in Exhibit A, attached hereto and made a part hereof, as if fully written below.

**SECTION II:** That the heretofore existing Section 1068.03 of the Codified Ordinances of the City of Kirtland, previously enacted and in force, be amended by the passage of this ordinance, and is hereby replaced as set forth in Section I hereinabove.

## **SECTION III:**

- (a) It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
- (b) This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City, and for the further reason to allow the City to properly oversee and manage the park to ensure the welfare of its residents; wherefore, this Ordinance shall be in full force and effect immediately upon its passage by the affirmative vote of five members of Council and approval by the Mayor, otherwise this Ordinance shall be in effect from and after its adoption at the earliest period allowed by law.

## § 1068.03 DISCHARGING FIREARMS; FIRES; SIGNS.

No person or organization while on the grounds of the Kirtland Recreation Park, unless prior written permission has been obtained from the park operator, shall:

- (a) Shoot a bow and arrow, discharge any firearm or fireworks or ignite or burn any sparkler;
- (b) Build any fire, except at places provided for that purpose;
- (c) Carry any shrub, flower, firearm, slingshot, axe, saw, bow and arrow, shovel or spade into such park;
  - (d) Post or display any sign, banner or advertisement, or offer anything for sale.
