RESOLUTION NUMBER 22-R-23

A RESOLUTION AMENDING RESOLUTION NO. 21-R-76 RELATING TO ESTABLISHING STANDING COMMITTEES OF COUNCIL, AND DECLARING AN EMERGENCY.

WHEREAS, Kirtland Codified Ordinance 220.11 bestows upon the President of this Council the power to appoint members of the Council to standing committees, subject to the approval of Council; and

WHEREAS, this Council passed 21-R-76 establishing various standing committees of Council; and

WHEREAS, due to the resignation of Kelly Wolfe and the appointment of Richard Lowery in her stead as Ward 1 Councilperson, the President of Council has decided to amend the Recreation, Utilities, and Planning & Zoning Committees to reflect the newly appointed council member; and

WHEREAS, all other previously approved standing committee members shall remain in effect.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:
