RESOLUTION NUMBER 22-R-58

A RESOLUTION AMENDING RESOLUTION NO. 22-R-10 RELATING TO ESTABLISHING RULES, TIME AND PLACE OF COUNCIL MEETINGS FOR THE PERIOD FROM DECEMBER 1, 2021, THROUGH NOVEMBER 30, 2022, AND DECLARING AN EMERGENCY.

BE IT RESOLVED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION I: Kirtland Council Rules, together with Robert's Rules of Order, will be used to govern the actions of Kirtland City Council.

SECTION II: Kirtland City Council will meet regularly twice each month at 7:00 p.m. on the first (1st) and third (3rd) Mondays at Kirtland Municipal Center, 9301 Chillicothe Road. The only exceptions to this rule are:

- (a) Monday, January 3, 2022 (New Year's Day observed). Council will meet on Wednesday, January 5, 2022.
- (b) Monday, January 17, 2022 (Martin Luther King, Jr. Day). Council will meet on Wednesday, January 19, 2022.
- (c) Monday, February 21, 2022 (Presidents' Day). Council will meet on Wednesday, February 23, 2022.
- (d) Monday, March 7, 2022. To accommodate the Board of Elections with regard to the set-up of voting equipment for the March 8 special election, Council will meet on Wednesday March 9, 2022.
- (e) Monday, May 2, 2022. To accommodate the Board of Elections with regard to the set-up of voting equipment prior to the Primary Election, Council will meet on Wednesday, May 4, 2022.
- (f) To provide for Summer Recess, Council will meet on Wednesday, July 6, 2022 and Monday, July 11, 2022. Council will meet once during the month of August, on the fourth Monday, to-wit: August 22, 2022.
- (g) Monday, September 5, 2022 (Labor Day). Council will meet on Wednesday, September 7, 2022.

- (h) *Monday, October 17, 2022. Due to scheduling conflicts, Council will meet on Monday, October 24, 2022.*
- (i) Monday, November 7, 2022. To accommodate the Board of Elections with regard to the set-up of voting equipment prior to Election Day, Council will meet on Wednesday, November 9, 2022.

SECTION III:

(a) It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

(b) This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health and safety of the City, and for the further reason that it is necessary to provide for the usual and customary operations of the Council of the City of Kirtland; wherefor, this Resolution shall be in full force and effect immediately upon its passage by the affirmative vote of five (5) members of Council and approval by the Mayor, otherwise this Resolution shall be in effect from and after its adoption at the earliest period allowed by law.
