**ORDINANCE NUMBER 23-O-41**

**AN ORDINANCE AMENDING ORDINANCE NO. 23-O-10  
RELATING TO THE APPROPRIATION FOR THE YEAR  
2023.**

**WHEREAS**, the City of Kirtland has passed an Appropriation Ordinance No. 23-O-10 to govern the expenditures within the City; and

**WHEREAS**, Ordinance No. 23-O-10 needs to be amended to reflect actual and projected expenditures;

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the City of Kirtland, County of Lake, State of Ohio, that:

**SECTION I:** To provide for the current expenses and other expenditures during the fiscal year ending December 31, 2023, the following sums be and they are hereby set aside and appropriated as set forth in the City of Kirtland Amended Appropriation for the year 2023, which is attached hereto and incorporated herein as Exhibit "A".

**SECTION II:** The City's Director of Finance is hereby authorized to draw warrants from any of the foregoing appropriations upon receiving proper Certificates and Vouchers, therefore, authorized by law to provide the same, or an ordinance or resolution of Council to make the expenditures.

**SECTION III:** It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

**SECTION IV :** This Ordinance shall take effect and be in full force upon the signature by the Mayor or as otherwise provided in Article I, Section 9, of the Charter of the City of Kirtland.
