**CITY OF KIRTLAND**

**ORDINANCE NO.: 23-O-71**

**AN ORDINANCE CREATING FUND 214 TO PROPERLY ACCOUNT FOR THE RECEIPT OF FUNDING RELATING TO ARPA'S FIRST RESPONDER GRANTS, AND DECLARING AN EMERGENCY.**

**WHEREAS**, the City has previously passed 23-R-69 and 23-R-70 wherein it agreed to accept grant funding from ARPA funds relative to the City's first responders in the amounts of \$20,000.00 and \$60,929.96, respectively; and

**WHEREAS**, a separate fund is required to be established under Ohio Revised Code Section 5705.09 to account for the revenue derived from sources other than the general property tax; and

**WHEREAS**, the Director of Finance has tentatively created Fund 214 to properly account for the receipt of said funds and asks this Council to formally create the fund for proper accounting.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

**SECTION I:** This Council hereby authorizes the Director of Finance to create Fund 214 to account for the receipt of grant funding received in accordance with 23-R-69 and 23-R-70 and hereby calls said fund "ARPA First Responder Grants".

**SECTION II:**

(a) It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

(b) This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City, and for the further reason that the fund must be created to properly coincide with the city's annual appropriations; wherefore, this Ordinance shall be in full force and effect immediately upon its

passage by the affirmative vote of five members of Council and approval by the Mayor, otherwise this Ordinance shall be in effect from and after its adoption at the earliest period allowed by law.
