## **RESOLUTION NUMBER 23-R-51**

A RESOLUTION AMENDING RESOLUTION NO. 23-R-16 RELATING TO ESTABLISHING RULES, TIME AND PLACE OF COUNCIL MEETINGS FOR THE PERIOD FROM DECEMBER 1, 2022, THROUGH NOVEMBER 30, 2023, AND DECLARING AN EMERGENCY.

**BE IT RESOLVED** by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

**SECTION I:** Kirtland Council Rules, together with <u>Robert's Rules of Order</u>, will be used to govern the actions of Kirtland City Council.

**SECTION II:** Kirtland City Council will meet regularly twice each month at 7:00 p.m. on the first (1st) and third (3rd) Mondays at Kirtland Municipal Center, 9301 Chillicothe Road, Kirtland, Ohio. The only exceptions to this rule are:

- (a) Monday, January 2, 2023 (New Year's Day observed). Council will meet on Wednesday, January 4, 2023.
- (b) Monday, January 16, 2023 (Martin Luther King, Jr. Day). Council will meet on Wednesday, January 18, 2023.
- (c) Monday, February 20, 2023 (Presidents' Day). Council will meet on Wednesday, February 22, 2023.
- (d) Monday, May 1, 2023. To accommodate the Board of Elections with regard to the set-up of voting equipment prior to the Primary/Special Election, Council will meet on Wednesday, May 3, 2023.
- (e) Monday, June 19, 2023 (Juneteenth). Council will meet on Tuesday, June 20, 2023.
- (f) To provide for Summer Recess, Council will meet on Wednesday, July 5, 2023 and Monday, July 10, 2023. Council will meet once during the month of August, on the third Monday, to-wit: August 21, 2023.
- (g) Monday, September 4, 2023 (Labor Day). Council will meet on Wednesday, September 6, 2023.
