RESOLUTION NUMBER 23-R-69

A RESOLUTION AUTHORIZING THE CITY TO ACCEPT THE OHIO AMBULANCE TRANSPORTATION GRANT FROM THE STATE OF OHIO OFFICE OF BUDGET AND MANAGEMENT, AND DECLARING AN EMERGENCY.

WHEREAS, the City has submitted an application to the State of Ohio's Office of Budget and Management for the receipt of the Ohio Ambulance Transportation Grant which provides premium pay to certain employees that worked through the covid pandemic; and

WHEREAS, the State of Ohio has informed the City that its grant application has been approved, and grant funds in the amount of Twenty Thousand Dollars (\$20,000.00) are available to the City to provide a premium payment to those first responders in the Kirtland Fire Department who provided services to the City during the covid pandemic; and

WHEREAS, it is necessary to accept said grant.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION I: This Council hereby authorizes the Mayor or his designee to accept a grant from the State of Ohio's Office of Budget and Management for an amount of Twenty Thousand Dollars (\$20,000.00) to provide a premium payment to those first responders in the Kirtland Fire Department who provided services to the City during the covid pandemic the City's Fire Department.

SECTION II: The Mayor or his designee is hereby authorized to execute all documents necessary to accept said grant, and all actions taken by the Mayor or his designee to accept said grant prior to the effective date of this Resolution are hereby ratified and approved.

SECTION III:

(a) It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

(b) This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the City, and for the further reason that the grant must be accepted immediately in order to provide continuing assistance to the City's Fire Department; wherefore, this Resolution shall be in full force and effect immediately upon its passage by the affirmative vote of five members of Council and approval by the Mayor, otherwise this Resolution shall be in effect from and after its adoption at the earliest period allowed by law.
