ORDINANCE NUMBER 24-0-49

AN ORDINANCE AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE TO ENTER INTO A CONTRACT TO PURCHASE ONE (1) ARI HETRA MOBILE COLUMN LIFT FOR THE CITY'S MECHANIC, AND DECLARING AN EMERGENCY.

WHEREAS, the Director of Public Service has determined that the City needs a lift for its mechanic to appropriately perform the duties required of that Department; and

WHEREAS, the Director of Public Service has recommended the purchase of one ARI Hetra Mobile Column Lift manufactured by ARI Hetra and sold by ARI Phoenix, Inc. pursuant to the State of Ohio Contract Number RS900921-3 with the specifications as outlined in the quote attached hereto as Exhibit A for a cost not to exceed \$55,160.20.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION 1: The Mayor and/or the Director of Public Service are hereby authorized and directed to enter into a sales agreement with ARI Phoenix, Inc. for the purchase of one (1) mobile column lift manufactured by ARI Hetra in accordance with Quote ARI27103 which is attached hereto and incorporated herein as Exhibit A. Said purchase is hereby authorized for a price not to exceed \$55,160.20.

SECTION 2: The Mayor and Director of Public Service are hereby authorized to sign any documents to complete the purchase as described herein and the Director of Finance is hereby authorized to expend the necessary funds to complete the transaction.

SECTION 3: It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4: This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the citizens of the City of Kirtland. The emergency is necessary in order to continue providing necessary services to the residents by providing ample tools and equipment to provide repair services of the City's vehicles. Therefore, this Ordinance shall be in full force and effect immediately upon its passage by the affirmative

vote of five (5) members of Council and approva in effect from and after its adoption at the earlies	l by the Mayor, otherwise this Ordinance shall be at period allowed by law.
