ORDINANCE NUMBER 24-O-6

AN ORDINANCE AMENDING ORDINANCE NO. 23-O-91 PROVIDING TEMPORARY APPROPRIATIONS FOR THE THREE-MONTH PERIOD ENDING MARCH 31, 2024.

WHEREAS, the City of Kirtland has passed a Temporary Appropriation Ordinance No. 23-O-91 to provide for current expenses and expenditures of the City during the three-month period ending March 31, 2024; and

WHEREAS, it has been recommended by the Finance Director that Ordinance No. 23-O-91 needs to be amended and the following sums be set aside and appropriated at this time:

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION I: The City Finance Director is hereby authorized to draw warrants for payments from the above-mentioned Funds and Levies (Total Appropriation of \$2,617,585.51) upon receiving proper certification and vouchers.

SECTION II: All payments shall be approved by those officers authorized by law to approve the same or upon receipt of legislation from this Council authorizing said expenditures.

SECTION III: No warrants shall be drawn or payment for salaries or wages made except to those persons employed under the authority of and in accordance with statutory law or City ordinances.

SECTION IV:

(a) It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

(b) This Ordinance shall take effect and be in full force upon the signature by the Mayor or as authorized provided in Article I, Section 9, of the Charter of the City of Kirtland.
