RESOLUTION NUMBER 24-R-17

A RESOLUTION AMENDING RESOLUTION NO. 23-R-78 RELATING TO ESTABLISHING RULES, TIME AND PLACE OF COUNCIL MEETINGS FOR THE PERIOD FROM DECEMBER 1, 2023, THROUGH NOVEMBER 30, 2024, AND DECLARING AN EMERGENCY.

BE IT RESOLVED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION I: Kirtland Council Rules, together with <u>Robert's Rules of Order</u>, will be used to govern the actions of Kirtland City Council.

SECTION II: Kirtland City Council will meet regularly twice each month at 7:00 p.m. on the first (1st) and third (3rd) Mondays at Kirtland Municipal Center, 9301 Chillicothe Road, Kirtland, Ohio. The only exceptions to this rule are:

- (a) Monday, January 1, 2024 (New Year's Day). Council will meet on Wednesday, January 3, 2024.
- (b) Monday, January 15, 2024 (Martin Luther King, Jr. Day). Council will meet on Tuesday, January 16, 2024.
- (c) Monday, February 19, 2024 (Presidents' Day). Council will meet on Wednesday, February 21, 2024.
- (d) Monday, March 18, 2024. To accommodate the Board of Elections with regard to the set-up of voting equipment prior to the Presidential Primary Election, Council will meet on Wednesday, March 20, 2024.
- (e) Monday, April 1, 2024. Due to scheduling conflicts, Council will meet on Wednesday, April 3, 2024.
- (f) To provide for Summer Recess, Council will meet on Monday, July 1, 2024 and Monday, July 8, 2024. Council will meet once during the month of August, on the third Monday, to-wit: August 19, 2024.
- (g) Monday, September 2, 2024 (Labor Day). Council will meet on Wednesday, September 4, 2024.

(h) Monday, November 4, 2024. To accommodate the Board of Elections with regard to the set-up of voting equipment prior to Election Day, Council will meet on Wednesday, November 6, 2024.
