

CITY OF KIRTLAND

ORDINANCE NUMBER 26-O-34

AN ORDINANCE AUTHORIZING THE CITY OF KIRTLAND TO ENTER INTO A CONTRACT TO PURCHASE ONE (1) FREIGHTLINER M2 106 PLUS AS SHOWN IN EXHIBIT A FROM CLEVELAND FREIGHTLINER, AND DECLARING AN EMERGENCY.

WHEREAS, the Service Director of the City of Kirtland has determined that it needs a new vehicle for its daily operations; and

WHEREAS, the City of Kirtland has been authorized by Council to participate in State contracts, which the Department of Administrative Services, Office of State Purchasing has entered into for the purchase of supplies, services, and equipment; and

WHEREAS, the Service Director has recommended the purchase of one (1) Freightliner M2 106 Plus through Cleveland Freightliner, a vendor who participates in Sourcwell, a joint purchasing program in accordance with Ohio Revised Code 9.48 with an amount not to exceed \$296,922.00; and

NOW, THEREFORE, IT IS HEREBY RESOLVED by the Council of the City of Kirtland, County of Lake and State of Ohio, that:

SECTION I: The Mayor and/or the Service Director are hereby authorized and directed to enter into a sales agreement with Cleveland Freightliner for the purchase of one (1) Freightliner M2 106 in accordance with Sourcwell Contract #032824-DAI, for an amount not to exceed \$296,922.00. Said contract and accompanying documents are attached hereto and incorporated herein as Exhibit A.

SECTION II: The Mayor and Service Director are hereby authorized to sign any documents to complete the purchase as described herein and the Director of Finance is hereby authorized to expend an amount not to exceed \$296,922.00 to complete the transaction.

SECTION III: It is found and determined that all formal actions of this Council concerning and relating to the passage of this Ordinance were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION IV: This Ordinance is declared to be an emergency measure necessary for the preservation of the public peace, safety and welfare of the citizens of the City of Kirtland. The emergency is necessary in order to continue providing necessary services to the residents by and from its Service Department. Therefore, this Ordinance shall be in full force and effect immediately upon its passage by the affirmative vote of five (5) members of Council and approval by the Mayor,

otherwise this Ordinance shall be in effect from and after its adoption at the earliest period allowed by law.
