Responding, Law Director Lallo stated there is active litigation against Richard's Maple in the Willoughby Municipal Court against the Landlord Richard's Maple.

Old Business:

Discussion Utility Trailer Definition.

Ronald Crouse, 8345 North Locust, addressed the commission. Mr. Crouse shared his continued concerns regarding his perception that the neighborhood continues to deteriorate. He provided copies of photographs of different areas throughout his neighborhood for the Commission members to view. The photographs will become a permanent part of the record of this meeting.

A discussion regarding City Ordinance 1268: R-1, R-2 and R-3 Residential Districts, followed. Mr. Lallo reviewed the Ordinance. Particularly addressing the language in Section 1268.04. regarding off-street parking in residential districts.

Chairperson Denk stated that based on the discussion he would like to see Ordinance 1268.04, as written, be enforced by the Zoning Department. Further stating that the Commission would prefer to not rewrite ordinances but implement enforcement of existing ordinances. Mr. Lallo discussed the litigation process when a violation is not corrected and reviewed the process.

Mr. Lallo inquired if the topic "Definition of Utility Trailer" needed to be discussed further. Responding Chairperson Denk stated this can be addressed in the future, if need be, based the discussion regarding carrying out the enforcement of violations to existing ordinances.

New Business:

A discussion regarding City of Kirtland Codified Ordinance Chapter 1290: Fences was held.

Discussion ensued. Mr. Denk requested a Resolution be prepared for presentation at the October 2024 Planning & Zoning Commission meeting for recommendation to Council regarding changes to Chapter 1290: Fences.

Mr. Denk requested the Clerk provide Public Notice that a Public Hearing regarding modifications to Chapter 1290: Fences will be held at the October 14, 2024, Planning & Zoning Commission meeting.
