Registration Procedures for Contractors

- 1) Complete the attached form in full. APPLICANTS must submit copies of registration from two (2) other communities or notarized forms from other businesses or customers showing prior work done. Electricians and plumbers must also submit copy of Lake County Building Department license or registration.
- 2) Application fee is \$75.00 which is good for only the year which this registration covers.
- 3) A surety bond in the amount of \$5,000 must be provided by the applicant's insurance company, showing work categories covered. The principal registration individual must sign the bond, as well as provide a Federal I.D. number or Social Security number.
- 4) Provide a Certificate of Insurance to the City of Kirtland, indicating evidence of liability insurance for bodily injury in the amount of at least \$100,000/\$300,000 and for property damage in the amount of at least \$50,000. Please note that the City of Kirtland should be named as additional insured on certificates if working on City buildings or property.
- 5) Provide a stamped, addressed envelope if you would like a printed copy of the Certificate of Registration mailed to you.
- 6) Certificate of Registration shall be for a term of one year, from January through December.
- 7) The City of Kirtland shall be authorized to revoke any and all certificates where contracting work is installed contrary either to the Ordinances of the City or the Lake County Building Department codes.
- 8) The City, by no means, is guaranteeing any workmanship, and will not make any recommendations of individual contractors to homeowners or businesses requesting such information. The City will only give current information if problems exist and persons need to contact a contractor who has not done quality work or finished an existing project.
